PARTICIPANT RISK ACKNOWLEDGMENT, RELEASE, AND INDEMNITY AGREEMENT

I HAVE READ, UNDERSTAND, AGREE AND ACKNOWLEDGE THAT:

1. "The Program" includes ___*programs* _ provided by _*Riverwalk Market Fair Inc.* _ to the Participant.
2. I am a validly registered and voluntary Participant in The Program.
